Highly motivated students between the ages of 16 to 18 are invited to participate in the exciting Teen Volunteer Program (TVP) at the National Museum of the Marine Corps (NMMC). Graduates of the training are Teen Hospitality Ambassadors trained to help Museum visitors better understand and appreciate the history of the United States Marine Corps.

Becoming a Teen Hospitality Ambassador is an opportunity for teenagers to explore history, develop skills in leadership, time management and public speaking, while at the same time making a significant contribution to the community.

Selection is based upon the application and parent or guardian's permission. Teen Hospitality Ambassadors are required to attend training, to volunteer at least eight hours a month, and are expected to remain in the program for at least one year.

**Training for the program will be held the last two weeks of July from 8:00 am – 12:00 pm, Monday through Friday. The training will be held at the National Museum of the Marine Corps at 18900 Jefferson Davis Highway, Triangle, VA 22172.**
